# <u>154/18</u> <u>Chairman's comments</u>

The Chairman announced to all the news that Kirton had been judged to be Best Kept Village in the Large village category in this year's CPRE competition. He thanked the contractors (grass/hedge cutting, watering), Cheers nurseries, Barbara the village Caretaker and The Friday Group for their combined efforts in achieving this. Not to forget the residents and businesses which have tended their properties too.
